## WTC/180/16 DECLARATIONS OF INTEREST:

Cllr. Yoxall declared a personal interest in Agenda Item 7.

#### WTC/181/16 PUBLIC PARTICIPATION SESSION:

Mrs Ma addressed the Council on safety on the very narrow public footpath on the A44 coming down the hill from Old Woodstock to the Black Prince and stated that she had seen three lorries mount the kerb onto this footpath. This was a danger to pedestrians and in particular to mothers with toddlers and pushchairs and pupils walking along the footpath to get to the primary school and back.

Mrs English supported Mrs Ma and had also seen a lorry mount the kerb. She suggested that a footbridge be constructed from Barn Piece estate across the River Glyme and the Water Meadows to Brook Hill so that it was no longer necessary to walk beside the road. She also complained about pollution levels on this stretch of road.

The Mayor explained that road safety on the A44 was a matter for Oxfordshire County Council and Woodstock Town Council had no power in the matter. The lack of funding is also a problem.

Cllr. Poskitt proposed and Cllr. M Robertson seconded the motion and it was

that a letter is sent to West Oxfordshire District Council to have a pollution monitor installed on the A44 in Old Woodstock
