WTC/192/14 QUESTIONS There were no questions submitted under standing order no. 8

With the agreement of the council the meeting brought item 6 forward on the agenda and took this matter next.

WTC/193/14 PLANNING APPLICATION 14/01497/FUL: 1 GLOVERS CLOSE, WOODSTOCK
Removal of garage and erection of new two storey dwelling (amended application).

Following extensive discussion Cllr Wray proposed that Woodstock Town Council makes no comment on this application. This was put to a vote and there were 4 votes in favour, 5 against and 1 abstention so the motion fell.

Cllr P Jay proposed, Cllr M Robertson seconded the motion, there were 6 votes in favour, 5 abstentions and the Council

RESOLVED that Woodstock Town Council reaffirms its previous **objection** to this planning application on the grounds of Planning Policy B2 of the WODC Local Plan which is a general reducing in standards of the street scene.

Cllr E Poskitt then left the meeting as she had previously declared pecuniary interest in the motion that would be discussed next.

WTC/194/14 MOTIONS PRESENTED TO COUNCIL

The following motion from Cllr P Jay had been submitted in accordance with WTC Standing Orders.

“The council reaffirms its policy towards the proposed development in East Woodstock, namely that, in agreement with the recent Town Meeting and Town poll, it opposes any development or urbanisation on green fields abutting and surrounding our town of Woodstock and confirms that the so-called ‘Town Partnership’ is a private organisation which does not speak for or with the approval of the Town Council on planning or any other matters. It calls upon the Neighbourhood Plan Working Group to convene with all possible speed to formulate proposals both for resisting the proposed development in East Woodstock and for guiding the future development of the town in the best interests of its residents and to report promptly. It appoints Councillor Yoxall as an additional member of the group.”

Cllr Jay moved an amended motion:

“The Council reaffirms its policy towards the proposed development in East Woodstock. It opposes the developers’ plans in their present form and calls upon the Neighbourhood Plan Working group to convene with all possible speed to formulate proposals both for resisting the proposed development in East Woodstock and for guiding the future development of the town in the best interests of its residents and to report promptly. It appoints Councillor Yoxall as an additional member of the group. It considers that the Town partnership is an organisation independent of the town council which does not speak for or on behalf of the town council.”

The amended motion was seconded by Cllr Stokes and agreed unanimously.
